Non-Disclosure and Confidentiality Agreement

By signing this Non-Disclosure and Confidentiality Agreement (this "Agreement"), the individual listed below is legally committing to maintaining the confidentiality of all below listed information provided by Cliff Media, LLC to "participating individuals" for the purposes of legal consent to appear in adult content.

This Agreement will be governed by and construed in accordance with the laws of the State of Oregon, without regard to the principles of conflict of laws. Each party consents to the exclusive jurisdiction of the courts located in the State of Oregon for any legal action, suit or proceeding arising out of or in connection with this Agreement. Each party further waives any objection to the laying of venue for any such suit, action or proceeding in such courts.
